

NBA Africa - 2025 Christmas Sweepstakes - South Africa

Official Rules

Void Where Prohibited.

1) Description: The NBA Africa 2025 Christmas Sweepstakes ("**Promotion**") is a random draw promotion. Odds of winning depend upon the total number of eligible entries received during the Promotion Period.

2) Eligibility: The Promotion is open only to residents of South Africa who are eighteen (18) years of age or older as at date of contest entry submission and who have a valid visa to enter the United Kingdom during the period of travel (January 2026) (each, an "**Entrant**").

Employees, officers, directors, agents and representatives of NBA Properties, Inc. ("**Sponsor**"), NBA Africa, LLC. ("**NBAA**"), the National Basketball Association ("**NBA**") and its member teams, and NBA Media Ventures, LLC (collectively, the "**NBA Entities**"), Idea Rebel Interactive Inc. ("**Administrator**"), and each of their respective parent companies, subsidiaries, affiliates, officers, governors, owners, distributors, retailers, agents, advertising/promotion agencies (hereafter collectively, "**Released Parties**"), and each such individual's immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate in the Promotion or receive a prize.

3) Promotion Period: The Promotion starts at 10:00:00 AM SAST on 17 December 2025 and ends at 11:59:00 PM SAST on 25 December 2025 ("**Promotion Period**"). Registration and entries must be submitted during the Promotion Period.

4) To Participate: During the Promotion Period, visit nbaafricacontests.com/christmas ("**website**") and click on the banners, buttons and/or links to access the Promotion registration page (the "**Promotion Registration**"). To register, complete and submit the Promotion Registration form according to the instructions provided, which includes creating an NBA ID account. In addition, you may be asked if you wish to receive promotional emails from the NBA. Consenting to receive promotional emails is optional and is not required for participation in this Promotion and will not impact your chances of winning.

There is a limit of one (1) Promotion Registration form submission per person and per email address per day for the duration of the Promotion Period. Additional registration forms or entries received from any such person or email address after the entry is received from that person or email address will be void. - 1 (one) prize consisting of a PlayStation 5 Slim
 - Total approximate prize value is \$550 USD (approximately 9,000 ZAR)

Prize 9: For one (1) Entrant who entered the Promotion on December 25, 2025 between 00:00:01 AM SAST and 11:59:59 PM SAST

- 1 (one) prize consisting of a PlayStation 5 Slim
 - Total approximate prize value is \$550 USD (approximately 9,000 ZAR)

Grand Prize - Prize 10: For one (1) Entrant who entered the Promotion at least once during the Promotion Period.

- One (1) prize consisting of a trip for two (2) to London, England to see the NBA London Game 2026 taking place on 18 January 2026 at O2 Arena, Peninsula Square, London SE10 0DX, United Kingdom. This prize includes the following components, with an approximate aggregate retail value of \$3,000 USD (approximately 52,000 ZAR):
 - Two (2) Economy class airline tickets from the closest international airport in proximity to the Winners residence, to an international airport near London, England.
 - Specific seat selection is the sole discretion of the NBA.
 - Flights will arrive in London on or about January 17, 2026. Exact dates and times of flights will be determined by the NBA.

 - Two (2) General Admission tickets to the NBA London Game 2026 taking place on 18 January 2026 at O2 Arena, Peninsula Square, London SE10 0DX, United Kingdom. Tickets to be chosen by the NBA at their sole discretion

Total aggregate retail value of all prizes combined is approximately \$4,900 USD (approximately 84,000 ZAR).

Entrants can only win one (1) daily prize (prize 1 through 9) during the Promotion Period. Entrants will receive one (1) entry for the Daily Prize on the day they entered and one (1) entry for the Grand Prize (Prize 10) for each day they enter the Promotion during the Promotion Period

- The Fourth Draw, through which one (1) eligible winner for Prize 4 will be chosen from Entrants who participated in the Promotion during the period on December 20, 2025, will take place on or about December 21, 2025 from all eligible Entries (the “**Fourth Draw**”);
- The Fifth Draw, through which one (1) eligible winner for Prize 5 will be chosen from Entrants who participated in the Promotion during the period on December 21, 2025, will take place on or about December 22, 2025 from all eligible Entries (the “**Fifth Draw**”);
- The Sixth Draw, through which one (1) eligible winner for Prize 6 will be chosen from Entrants who participated in the Promotion during the period on December 22, 2025, will take place on or about December 23, 2025 from all eligible Entries (the “**Sixth Draw**”);
- The Seventh Draw, through which one (1) eligible winner for Prize 7 will be chosen from Entrants who participated in the Promotion during the period on December 23, 2025, will take place on or about December 24, 2025 from all eligible Entries (the “**Seventh Draw**”);
- The Eighth Draw, through which one (1) eligible winner for Prize 8 will be chosen from Entrants who participated in the Promotion during the period on December 24, 2025, will take place on or about December 25, 2025 from all eligible Entries (the “**Eighth Draw**”);

- The Ninth Draw, through which one (1) eligible winner for Prize 9 will be chosen from Entrants who participated in the Promotion during the period on December 25, 2025, will take place on or about December 26, 2025 from all eligible Entries (the “**Ninth Draw**”);
- The Tenth Draw, through which one (1) eligible winner for Prize 10 (Grand Prize) will be chosen from Entrants who participated in the Promotion during the Promotion Period, will take place on or about December 26, 2025 from all eligible Entries (the “**Tenth Draw**”);

An Entry selected will be eligible to win one (1) Prize according to the list of Prizes and dates above, (each a “**Prize Winner**”). The odds of winning a Prize will depend on the total number of eligible Entries received during the Draw or Promotion Period.

In the event of any error of any kind whatsoever, more potential winners are selected than specified in these Official Rules, the Sponsor reserves the right to hold a random draw amongst all potential Prize claimants to award the correct number of Prizes.

7) Winner Notification: The selected entrants for the Prizes will be contacted via email by a representative of the NBA Entities or Idea Rebel Interactive Inc. by the following dates; December 19, 2025 for the First Draw, December 20, 2025 for the Second Draw, December 21, 2025 for the Third Draw, December 22, 2025 for the Fourth Draw, December 23, 2025 for the Fifth Draw, December 24, 2025 for the Sixth Draw, December 25, 2025 for the Seventh Draw, December 26, 2025 for the Eighth Draw, December 27, 2025 for the Ninth Draw and the Tenth Draw.

The Winners will be notified by e-mail to the e-mail address provided during the registration process. Entrants are solely responsible for checking their e-mail inboxes (and spam mailbox, if applicable) to see if they are the Winner.

To claim the Prize, a Winner must follow and complete the instructions in the Winner Notification email within seventy-two (72) hours of the email notification being sent to a Winner. If a Winner does not claim the Prize within this timeframe, the Winner’s claim will be automatically withdrawn and the Promoter will re-award the Prize to an alternate Winner selected by random draw in accordance with these Official Rules.

The Promoter does not accept any responsibility if a Winner is unable to claim the Prize.
